### Techniques for Managing Special Events

This training will identify the complex nature associated with special events and the need for effective planning, proper management, policy application, and enforcement at the event. The training will demonstrate how alcohol at special events increases its complexity and how implementation of various alcohol

policies and enforcement of those policies can be effective in curtailing alcohol related problems often associated with such events. Outcomes of poor planning and effects of zero tolerance will also be reviewed. Key points covered in the training include:

- Should alcohol be allowed at special events.
- Planning.
- Liability issues.
- Awarenes building
- Enforcement efforts.
- Alcohol control techniques.

- Costs associated with special events and who should bear costs.
- Training of Key Stakeholders (bar personnel, enforcement, volunteers).
- Types of events (Concerts, sporting events. fairs / festivals, etc...)

From 2002 to 2019, Ms. McGee was a consultant for the Pacific Institute for Research and Evaluation's Underage Drinking Enforcement Training Center. She is also an IADLEST Nationally Certified Law Enforcement Trainer and regularly conducts trainings on topics such as developing and sustaining community coalitions, environmental management, working with college communities, compliance check investigations (alcohol and tobacco), controlled party dispersal, shoulder tap operations, false identification, media advocacy, managing special events, social media, and working effectively with retailers.

Ms. McGee has been a featured speaker and panelist at numerous national and state conferences on alcohol policy issues. In 2014, she was selected as an FDA Tobacco Regulatory Science Fellow by the Institute of Medicine of the National Academies. She spent a year in residency at the FDA Center for Tobacco Products in Silver Spring, Maryland, where she assisted with implementing and enforcing the Family Smoking Prevention and Tobacco Control Act.

Ms. McGee holds a BA in political science from the University of Missouri–Columbia and a JD from the St. Louis University School of Law. She is licensed to practice law in Missouri and Illinois.
